

Managing Fake News on the Hardest Place to be Muslim Women

An online news publication "Fair Planet" reported that there are three countries that were the most difficult places to be a Muslim woman. The three listed are: Saudi Arabia, Iran and Afghanistan. The reasoning was quoted as the following;

"From restrictions on education and employment to denying fundamental human rights, these countries present a stark reality for millions of women. The system made headlines recently in Afghanistan when the Taliban banned women from "hearing other women's voices."

But where is Sharia law particularly harsh on women? From restrictions on education and employment opportunities to limited access to healthcare and denying fundamental human rights, these countries present a stark reality for millions of women.

Comment:

The attacks on the Islamic way of life and ideological viewpoint in the article represent the typical cheap and overused verbiage that the orientalist, colonialists and enemies of history have used to give some moral equivalence to the Western culture.
