## A Delegation from Hizb ut Tahrir / Wilayah Sudan Meets

## The Head of the Steering Committee of the Bar Association in Port Sudan

(Translated)

A delegation from Hizb ut Tahrir / Wilayah Sudan, led by Ustaadh Nasser Ridha, the Head of the Central Communications Committee of Hizb ut Tahrir in Wilayah Sudan, accompanied by Ustaadh Abdullah Ismail, Member of Hizb ut Tahrir, visited Ustaadh Mohamed Ahmed Al-Souqi, the Head of the Steering Committee of the Bar Association, at his office in Port Sudan on Wednesday, 27 Rabi' al-Akhir 1446 AH corresponding to 30 October 2024 CE.

At the beginning of the meeting, Ust. Nasser Ridha introduced Hizb ut Tahrir as a political party striving to revive Islamic life by establishing a second Khilafah Rashidah (Rightly guided Caliphate) on the method of the Prophethood. He explained that, in pursuit of this goal, the Hizb engages in political activities, lectures, forums, and provides Islamic perspectives on current events and issues through publications and statements. The Hizb also maintains direct contact with all people, particularly politicians, scholars, thinkers, community leaders, and others, to promote the central cause of Muslims: the establishment of Allah's rule on Earth through Islamic authority, following the same method pursued by Prophet Muhammad (swt) and later by his Khulafa' Ar-Rashedeen (Rightly Guided Caliphs) and their successors, until the Khilafah (Caliphate) was abolished in 1924. Since then, Muslim lands have been divided and governed by systems and laws unrelated to Islam. The duty of the Muslim Ummah today, he emphasized, is to work towards restoring Islamic systems and rulings under the Islamic State, Khilafah Al-Rashidah (Righteous Caliphate) on the method of Prophethood.

Ust. Al-Souqi commended Mr. Nasser's address, stating that there is indeed fertile ground for the establishment of the Khilafah, though it requires great effort and patience. He concluded by mentioning his intention to visit the Hizb's office in Port Sudan.

At the end of the meeting, Ust. Abdullah, a member of the delegation, thanked Ust. Al-Souqi for his hospitality, warm reception, and interest in the matters of the Ummah.
